

Channelkeeper Takes Action to Protect Public Health from Fracking

On February 13th, Channelkeeper petitioned two government agencies - the Ventura County Environmental Health Division and the California Division of Oil, Gas and Geothermal Resources - to take action to protect public health and the environment from contamination emanating from oil fields along the north coast of Ventura County. Citing a recent scientific study, Channelkeeper highlighted findings that indicate fracking and enhanced recovery activities by nearby oil producers may be contaminating coastal streams and beaches. Our letters urged these agencies

to heed the study's recommendations by installing signage to warn the public to stay

out of the water where the contaminated creeks flow to the beach. We also called for a moratorium on further fracking and injection activities in the area until the appropriate government agencies can conduct tracer tests to verify that operations aren't polluting the water.

Desalination Water Rate Increase Hearing March 10



Next Tuesday, March 10th at 2:00 pm, the Santa Barbara City Council will hold a public hearing on its proposal to raise water rates to pay for the reactivation of the City's mothballed desalination plant. A typical household with moderate monthly water usage of 12 Hundred Cubic Feet (HCF) - or approximately 9,000 gallons - will face a 38% rate hike, or nearly \$30/month. This means that the average household in Santa Barbara will pay approximately \$3,600 over the next decade to reactivate the desalination plant, even if the rains return and desalinated water is no longer needed. The rate increase could potentially be less if the City secures a lower interest loan, or much more if the drought continues and the plant's capacity is expanded. If you want to weigh in on the rate increase or get more information, please attend the City Council hearing on March 10th. After considering public input received on that date, City Council will decide whether to adopt the higher rates on Tuesday, March 17th at 2:00 pm. Then, depending on the amount of rain we get in the next few months, City Council will decide whether or not to proceed with reactivating the desalination plant in June, and if they do, the higher rates will go into effect on July 1, 2015 and the plant will deliver water in fall 2016.

Speaking out in Sacramento to Protect Rivers and Water Quality



As a member of the California Coastkeeper Alliance (CCKA), Santa Barbara Channelkeeper is fortunate to have strong representation in Sacramento on state water policy processes. In February, Channelkeeper teamed up with CCKA to represent the interests of citizen water quality monitoring groups at a hearing before the State Water Resources Control Board (SWRCB). Channelkeeper's Stream Team Program is one of the most robust and longest running citizen monitoring efforts in the entire state, and we leveraged our expertise to help ensure that citizen monitoring data is utilized by the SWRCB to assess the health of our waterways, as required by

law. Channelkeeper also submitted a 40-page comment letter to the SWRCB in February in response to their recent proposal to declassify the Ventura River as impaired by over-pumping and water diversions. Available data clearly demonstrate that over-pumping and diversions are negatively impacting water quality and aquatic habitat in the River, and numerous regulatory agencies have adopted similar findings. Channelkeeper is currently engaged in Legal proceedings against the SWRCB and City of Ventura to prevent over-pumping in the Ventura River. Channelkeeper will travel to Sacramento again on April 7th to testify before the SWRCB and urge them to retain the impairment classification, which carries with it specific requirements to address the impairment.

Channelkeeper and Our Partners Cleanup 1,300 Pounds of Trash!

Channelkeeper, Santa Barbara Adventure Company and Island Packers teamed up with several other local environmental organizations, businesses, and government agencies to remove over 1,300 pounds of trash from Santa Cruz Island and to raise awareness about the growing problem of trash accumulating in our oceans. Nearly 40 volunteers scoured a two-mile stretch of beach



on the southeast side of Santa Cruz Island, where we found derelict fishing gear washed ashore from heavy winter swells scattered everywhere. Plastic garbage was the next most common type of trash we encountered. The trash was shuttled by kayak and zodiac raft and then transported back to the mainland by Island Packers, where it was weighed and disposed of by the National Park Service. An estimated one ton of additional derelict fishing gear had to be left on the beach for lack of space on the return trip.

California Bans the Bag, But Bag Makers Fight Back



Last fall, the California Legislature enacted Senate Bill 270, making California the first state in the nation to adopt a law to ban plastic bags at grocery retailers statewide effective July 1, 2015. However, the plastic bag industry spent \$3.1 million (almost all from out-of-state sources) to collect signatures to try and overturn the bag ban. Enough signatures were gathered and certified at the end of February, so implementation of the bag ban will be delayed and a referendum will be placed

on the November 2016 ballot asking California voters to decide whether to overturn the ban. Meanwhile, Channelkeeper and our bag partners have resumed our advocacy efforts for other local municipalities along the South Coast to join the cities of Santa Barbara and Carpinteria in enacting local bag ordinances. If you live in Goleta or unincorporated areas of Santa Barbara County, please let your elected officials know that you support a plastic bag ban, and stay tuned for opportunities to get involved.
