Major Victory to Curb Ag Pollution!

For more than a decade, Channelkeeper has fought to protect local waterways from agricultural pollution. We scored a big win in this David and Goliath battle last month when the State Superior Court ruled in our favor on a lawsuit Channelkeeper and our partners filed in 2013 challenging the adequacy of regulations adopted by the State Water Board to control polluted discharges from irrigated agricultural lands on

California's Central Coast. The Court's ruling agreed with our arguments that the Central Coast "Ag Order" fails to comply with State law and is not in the public interest because it will not lead to quantifiable improvements in water quality or even arrest the continued degradation of the region's waters caused by agriculture. This is a major victory which will set the bar for how agricultural pollution is regulated throughout California. The Court ordered the State Water Board to create new rules to better protect surface and ground water from agricultural pollution. Channelkeeper will play a lead role in that process to ensure that the new rules address the concerns laid out in our lawsuit and will lead to real and verifiable improvements for waters impacted by agricultural discharges in our region.

Another Critical Win in Our Lawsuit to Restore Flows in the Ventura River



Channelkeeper scored another big victory in our groundbreaking lawsuit to restore flows to the Ventura River on August 26th.

The City of Ventura pumps hundreds of millions of gallons of water from the river each year, often completely dewatering parts of the river during critical dry weather periods and causing harm to habitat, endangered species, water quality, and recreation. The State Water Resources

Control Board (SWRCB) has officially designated the Ventura River as impaired by excessive pumping and diversions, and it has a constitutional duty to prevent the unreasonable use of the state's waters. Despite this, the City continues to pump, and the SWRCB has done nothing, putting the health of the river in serious jeopardy.

Download the Waterkeeper Swim Guide app for realtime water quality data at local beaches As a result, Channelkeeper filed a lawsuit last September seeking to compel the SWRCB to analyze the reasonableness of the City's use of the Ventura River. At our first hearing in April, the California Superior Court overruled the City's and SWRCB's objections and affirmed that the SWRCB has a mandatory duty to prevent unreasonable use of state waters. In response, the City attempted to bog down our case by filing cross-complaints against every other water right holder in the watershed, arguing that everyone's uses must be considered together. At our second hearing on August 26th, the Court again sided with Channelkeeper by forcing the City to drop its cross-complaints. Our hope is that the SWRCB will now agree to analyze the City's use of the river, and that ultimately that analysis will force the City to better balance its pumping to meet residential and municipal demand with the need to preserve in-stream flows for nature, fish and recreation.

As part of work to support the response to the Plains All American Oil Spill, Channelkeeper has been supporting a package of bills introduced by our local reps, State Senator Hannah Beth Jackson and Assemblymember Das Williams, to better protect our ocean and coast from future oil spills. On August 22nd, Channelkeeper participated in #CrudeAwakening, a paddle to Platform Holly organized by Patagonia and Surfrider to raise awareness and rally support for this legislation. The bills - SB788, SB414, SB295 and AB864 - have been making their way through various committees. Unfortunately, SB788 - which would have closed the loophole in the California

Coastal Sanctuary Act to prevent new offshore drilling in Tranquillon Ridge - died in the Assembly Appropriations Committee last week due to heavy opposition by the oil industry, but the other three bills passed out of committee and are headed to the floor, and we **NEED YOUR HELP** to get them passed! Oil Closes Summerland Beach

On August 21st, the Santa Barbara County Public Health Department closed Summerland Beach due to "strong petroleum odors along with significant amounts of oil in the water and oil on the beach." Although official reports have not yet confirmed the source, it is likely the oil is leaking from a poorly abandoned well, known as the Becker Well, located in the surf

zone at Summerland Beach. This well is one of several legacy wells in the area that were improperly capped after the oil boom in the early 1900s.

Earlier that week, Channelkeeper joined other environmental advocates to urge the State Lands Commission (SLC) to address the Becker Well since



conditions have worsened significantly in recent months. While the SLC did vote to proceed with an investigation, conditions had gotten so bad that the Public Health Department closed the beach to protect public health. The beach was re-opened on August 24th but a warning remains in place as oil and tar are still present in the water and on the beach. With local and state agencies now paying attention to this problem, Channelkeeper hopes meaningful action will be taken to address the leaking Becker Well as well as other poorly abandoned legacy wells off our coast.

Thanks for helping us keep our beaches and ocean clean!


Creek Week is September 19th - 27th
