The California coast is iconic for its breathtaking scenic views, spectacular beaches and incredible recreational opportunities. The preservation and protection of this resource has been achieved thanks to the <u>California Coastal Act</u> and the <u>California Coastal</u> <u>Commission</u>, whose mission is

to protect, conserve, restore, and enhance the environment of the California coastline.

Unfortunately, however, <u>California's coastal legacy is under attack</u>. The Coastal Commission's independence and leadership as an agency is threatened from a behind-the-scenes effort to oust its Executive Director, Dr. Charles Lester. This attempted upheaval is a direct attack on the Coastal Act, designed to gain control over the Coastal Commission's independent staff and make the Commission more "developer-friendly."

On February 10th the Coastal Commission will hold a hearing in Morro Bay to decide whether to terminate Dr. Lester. In the face of intense pressure from developers to build on every remaining inch of our coast and passionate advocacy by environmentalists to protect and preserve the last remaining stretches of undeveloped coast, Dr. Lester has done a good job moving sound policy and bringing parties on both sides together to compromise. It is unclear what he had done to merit termination.

Join Channelkeeper and a broad coalition of coastal and environmental advocates working to prevent this coup by <u>telling the California Coastal</u> <u>Commission</u> that you support the Coastal Act and Executive Director Lester.

"After the Spill" Speaker Series Next Session - February 10th

> In an effort to help our community understand the response to the Plains All American oil spill, the impacts it has caused, and issues related to oil development and spill response in our region more broadly, Channelkeeper has organized a series of free public lectures featuring relevant government officials,

# Channelkeeper Advocates to Protect Our Coast from Dangerous Oil Trains



This week, Channelkeeper will join several other environmental groups, local governments, school districts, and emergency responders' unions to urge the San Luis Obispo (SLO) County Planning Commission to deny Phillips 66's proposal to expand oil train capacity at the Santa Maria Refinery. Our primary concern with the project is the

additional five oil trains (80-100 rail cars each) per week that would travel along the coast, passing through or near residential areas, schools, endangered species habitat, public beaches, Marine Protected Areas, and tourist destinations, potentially impacting counties far beyond SLO. The Environmental Impact Report for the project reveals that the additional trains would significantly increase cancer risk, while an oil train accident along the line could result in catastrophic damage to sensitive habitats, tourism, and public health. A recent <u>report by</u> <u>Waterkeeper Alliance</u> found that rail car accidents have increased in recent years despite additional regulation and improved technology. The risks are simply too great to allow this project to move forward. Public testimony will be heard by the SLO Planning Commission this Thursday and Friday, February 4-5.
