Another Major Victory in the Fight Against Agricultural Pollution

Channelkeeper scored a major victory on May 19th when the Los Angeles Regional Water Board updated its regulations to curb pollution from agriculture in LA and Ventura counties. The new "Ag Order" contains some of the strongest protections for streams, rivers and wetlands in the entire state. Channelkeeper was a lead environmental advocate in this process,



successfully securing key new provisions including:

- date-certain timelines for compliance with water quality standards for farmers;
- enforceable water quality limits for farm discharges;
- individual farm monitoring to verify compliance with water quality standards; and
- well testing requirements to protect rural farm workers from drinking contaminated water.

These provisions do more to protect surface waters from agricultural pollution than those currently in place in any other region in California. While this is a giant step forward, protections for groundwater from ag pollution in LA and Ventura counties remain relatively weak. Channelkeeper will continue to work on further strengthening ag pollution regulations as they evolve in our region and others throughout California.

One Year After the Refugio Oil Spill

A lot has happened in the past few weeks as the one-year anniversary of the Refugio Oil Spill came and went. The federal Pipeline Hazardous Materials Safety Administration (PHMSA) issued its Failure Investigation Report summarizing its findings about what caused the spill - namely, Plains All American Pipeline's failure to protect against, detect and mitigate severe external corrosion of the pipeline and to detect and respond to the rupture in a timely manner.

District Attorney announced that Plains was indicted by a grand jury on 46 criminal charges - including 4 felony charges. Channelkeeper applauded the indictment as sending a strong message to Plains and other oil operators in our region that they will be held accountable for spills and the damage they cause to our environment and economy.

Channelkeeper spoke at a press conference on the spill anniversary to highlight our ongoing work related to the spill, including:

our ongoing lawsuit with EDC to obtain information from PHMSA about

inspections and oversight of the pipeline that ruptured;

- participating in meetings of the LA/Long Beach Area Committee to ensure that lessons learned from the spill are incorporated into our region's oil spill contingency plan;
- collecting standardized data on tar ball coverage, size, and characteristics on 16 beaches from Ventura to Gaviota on a quarterly basis in order to establish a baseline of what constitutes "normal" tar ball coverage on South Coast beaches from natural seeps, which will help inform the identification and clean-up of future spills;
- tracking and weighing in on the Natural Resource Damage
 Assessment process to support appropriate funding and projects
 to restore the damage caused by the spill;
- supporting Senator Hannah Beth Jackson's SB 900 to cap leaking legacy wells along our coast;
- opposing the Phillips 66 Oil Train proposal;
- tracking Venoco's oil proposals at Ellwood and Carpinteria; and
- KEEPING WATCH to protect our precious coast from spills.

Obviously, none of this work was planned, but Channelkeeper is committed to helping our environment and community recover from the spill and to do all we can prevent a similar tragedy from happening again. 10th Annual Operation Clean Sweep a Success!

Channelkeeper teamed up with partners from the Channel Islands National

Marine Sanctuary, Santa Barbara Surfrider, the Santa Barbara Maritime Museum, harbor dive businesses and volunteers from the local boating community to clean up the Santa Barbara Harbor as part of the Santa Barbara Waterfront Department's 10th annual "Operation Clean Sweep" on May 7th. More than 45 dock volunteers and divers



removed 1.5 tons of garbage from the seafloor below Marina 4, including barrels, pipes, chairs, buckets, liquor bottles, milk crates, and a full-size porcelain toilet. This year's clean-up brought the 10-year total of junk removed from the bottom of the Santa Barbara Harbor to 17.5 tons (35,400 pounds)!
