Welcome to a new section of our monthly enewsletter, which we will use to keep you informed about the Trump administration's latest efforts to weaken critical environmental protections, what Channelkeeper and our partners are doing to address them, and how you can help.

On February 24, 2017, President Trump issued an Executive Order (Exec. Order No. 13777, "Enforcing the Regulatory Reform Agenda") which requires the US EPA and other federal agencies to establish Regulatory Reform Task Forces to evaluate existing regulations and make recommendations regarding those that should be repealed, replaced or modified to make them less "burdensome" on the American people. Santa Barbara Channelkeeper joined Waterkeeper Alliance and 120 other Waterkeeper organizations in submitting comments to EPA last month in vehement opposition to the withdrawal, modification or revocation of any EPA regulation that results from Executive Order 13777. Channelkeeper and Waterkeepers across the nation rely on EPA regulations to protect our waterways and communities from pollution, and President Trump's Executive Order is a direct threat to our right to clean water. On April 28th, President Trump signed another Executive Order, "Implementing an America-First Offshore Energy Strategy," which mandates a "review" of any National Marine Sanctuary designated or expanded within the past ten years. This includes our beloved Channel Islands Sanctuary (because of minor boundary adjustments made in recent years), as well as

California's three other Sanctuaries - Monterey Bay, Cordell Bank and Greater Farallones. This now-pending interagency evaluation is expected to prioritize any potential for offshore oil and gas or frozen methane hydrates and subsea minerals that could be exploited if protection is removed. Beach Report Card Gives Mixed Reviews for South Coast Beaches

According to Heal the Bay's 2016-2017

Beach Report Card, water quality at
Santa Barbara and Ventura county
beaches this past year was good to
excellent during dry weather and, in
Santa Barbara, extremely poor during wet
weather. Santa Barbara's winter dry
weather water quality was good, with
93% of monitored beaches receiving A or
B grades. Water quality at Santa Barbara

beaches during wet weather significantly decreased, with 80% of the monitored locations received a C-F grade. Grades for the summer dry months were not available due to lab errors.

Twelve beaches scored lower than a "B" during wet weather - Refugio State Beach (F), El Capitan State Beach (F), Goleta Beach (F), Hope Ranch (C), Arroyo Burro (F), Leadbetter Beach (F), East Beach at Mission Creek (F) and at Sycamore Creek (F), Butterfly Beach (C), Hammond's Beach (D), Summerland Beach (D) and Carpinteria State Beach (D). Beach water quality at Ventura County beaches was excellent this past year, with 100% of monitored beaches receiving an A grade during dry summer weather and 94% receiving an A grade for dry winter weather. In wet weather, 80% of monitored locations in Ventura County received A or B grades.
