Two weeks ago, Channelkeeper asked you to help us raise \$5,000 so we could buy a new radar for our boat, the *R/V Channelkeeper*, and the response was overwhelming! Thanks to generous water lovers like you, **we raised \$2,500** in **just two days (!)** and were able to leverage a \$2,500 matching challenge from an anonymous donor. Now we can safely resume our on-the-water pollution patrols, including pre-dawn cruise ship patrols, to keep watch and defend your right to clean water. We are incredibly grateful for this quick and enthusiastic outpouring of support from our community - many thanks to all who contributed!

Blue Resistance

One of President Trump's first major environmental actions was his issuance of an Executive Order to Review the 'Waters of the US' (WOTUS) Rule, which defines which waterways are covered by the Clean Water Act. In response, the US EPA and Army Corps of Engineers announced in July that they planned to rescind the Obama-era WOTUS definition and revert to the previous regulations while they rewrite the Rule,



undoubtedly in a way that will significantly reduce Clean Water Act protections for smaller waterways and wetlands. Fortunately, they've already received a flood of comments opposing this plan of action and, in response, recently announced that they would extend the comment deadline to

September 27th. Click here to learn more and submit comments.

Fortunately, California is pursuing a comprehensive strategy to respond to federal environmental rollbacks like this. For example, the State Water Board is currently soliciting comments on a policy to protect California's endangered wetlands, which provide critical water supply, water quality, and flood mitigation benefits. California has already lost more than 90% of its historic wetlands, and efforts like the WOTUS rollback put these valuable habitats at even greater risk. Channelkeeper is working with California Coastkeeper Alliance and other partners to prepare comments to ensure that the state exercises its authority and develops an effective and enforceable Wetlands Policy. That's why the wetlands policy, which would allow the Water Boards to use state law to protect California's wetlands even if federal Clean Water Act protections are reduced. Protecting the Channel from Offshore Oil Leasing

The Trump administration is threatening to open our shores to new and expanded offshore oil development by initiating a new Five-Year Leasing Plan, despite the Obama Administration's



certification of the 2017-2022 plan after a multi-year public process. The entire Pacific Coast (including the Santa Barbara Channel) has been excluded from the five-year plans for the past 25 years, and California hasn't issued a new lease in State waters since the devastating 1969 oil spill. This new plan threatens the progress California has made to protect our coastal resources and to transition from dirty fossil fuels toward cleaner, renewable energy sources. Channelkeeper

has submitted comments urging that the Santa Barbara Channel remain excluded from the plan, and will continue to participate in the public review process as it moves forward. Click here for more information.

Coastal Cleanup Day September 16


