

### ACTION ALERT! Offshore Oil Bills Headed to Governor's Desk

Two state bills that will help protect California's environment, economy and communities from new oil and gas leasing off our shores have passed the California Legislature and are on Governor Brown's desk. Senate Bill 834 (Jackson-Lara) and Assembly Bill 1775 (Limón-Muratsuchi) would prohibit the State Lands Commission from approving new, modified, or extended leases for oil and gas production or associated infrastructure (including pipelines) in state waters that would result in increased production from federal waters. Santa Barbara Channelkeeper and our friends at California

Coastkeeper Alliance have been actively supporting these bills throughout the legislative session and are asking you to help us take them to the finish line by urging the Governor to sign these bills into law. # ACTION ALERT! Local Watersheds Targeted for Fracking!

The federal Bureau of Land Management (BLM) is proposing to open new leases for oil development and fracking on federal land



and mineral estates in our area, including in the upper Carpinteria Creek watershed, the foothills above Solimar and Faria beaches, and upper Thatcher Creek in the Ventura River watershed. BLM is initiating a study on the environmental impacts of the proposed new leases, and they are currently soliciting comments from the public regarding what types of environmental impacts should be examined. Unfortunately, BLM is following new Trump Administration guidelines for environmental review which limit the amount of time it will spend studying environmental impacts and even impose page limits on the final EIR. The public has until September 7th to weigh in on what environmental concerns should be analyzed, and to demand a thorough environmental review process.
