Federal Judge Halts Offshore Fracking Pending Further Review



Channelkeeper and EDC recently scored a big victory in our effort to stop the federal government from heedlessly allowing fracking and other "well stimulation techniques" (WSTs) at offshore oil platforms in southern California. Channelkeeper and the Environmental Defense Center filed a lawsuit in 2016 challenging the Bureau of Ocean Energy Management and Bureau of Safety and Environmental Enforcement for approving permits for WSTs at offshore platforms without first fully assessing and addressing potential impacts to the environment and threatened and endangered species. On November 9th, the court issued an injunction **PROHIBITING THE APPROVAL OF ANY NEW PERMITS** for WSTs until the US Fish and Wildlife Service completes its review of potential impacts to threatened and endangered species. The court also ruled that WSTs cannot occur offshore of California until the Coastal Commission can review potential harms to the coastal zone.

Progress on the Frontline Battle Against Agricultural Pollution



On the heels of our September <u>court</u> <u>victory</u>, the Central Coast Regional Water Quality Control Board is now proposing to take a huge step forward in how it protects surface waters and groundwater from agricultural pollution. Citing guidance from the recent Appellate Court ruling in our favor, the Regional Board is, for the first time ever, proposing actual limits on how much nitrogen (fertilizer) can be

applied by farmers in order to protect groundwater from contamination. Other new mechanisms being proposed, such as firm timelines for compliance to achieve water quality standards, should help improve water quality conditions throughout the Central Coast if adopted and implemented. The Regional Board is currently soliciting public comments on its proposed new Central Coast Ag Order, and Channelkeeper will continue to advocate for stronger protections against agricultural pollution as the process unfolds.

!!URGENT!! The Ventura River needs your help!

Channelkeeper has been providing <u>updates</u> on our work to stop the City of Ventura from pumping



the Ventura River dry. For the past two weeks we have been asking community members to email the Ventura City Council to urge them to manage this water resource responsibly and to engage in a productive dialogue that results in measures that balance the needs of the river with the City's water supply needs. King Tides are Returning to Santa Barbara

King Tides will be hitting our shores again on December 22-23 and January 20-21, providing a glimpse of how rising sea levels caused by climate change could impact our

shoreline. Although king tides are naturally occurring and predictable, they are particularly high compared to tides throughout the rest of the year and thus offer an opportunity to see how infrastructure and ecosystems may be impacted as sea level rises, since the high tides of today could be the norm in the future.
