### Remembering the 1969 Santa Barbara Oil Spill

Fifty years ago Monday was a critical turning point in history. On January 28, 1969, Platform A in the Santa Barbara Channel experienced an uncontrolled blowout which lasted for eight days and created a slick that covered over eight hundred square miles of ocean from the Channel Islands to the Mexican border. The blowout, which ultimately released more than three million gallons of oil over the course of several months and blackened beaches along forty miles of coastline, is cited by many as the catalyst for the birth of the modern environmental movement in the United States. In its wake, Earth Day and numerous environmental groups were born and a wave of environmental legislation was enacted. The State of California has not issued a new oil lease in State waters since the '69 spill. It was a game-changer. Now, a half-century later, we find ourselves at another critical turning point... # Santa Barbara to Expand Desalination Plant Without ANY Environmental Review or Upgrades

The Santa Barbara City Council voted unanimously yesterday to move forward with expanding its desalination plant by 60% in order to provide drinking water to



Montecito. This expansion will result in a major increase in water bills, energy use and greenhouse gas emissions and will take a massive death toll on marine life. Channelkeeper testified before the Council, urging them to address these environmental impacts when they expand the plant by powering it with 100% renewable energy, upgrading its existing open ocean intakes to subsurface intakes, and conducting a full Environmental Impact Report to assess and appropriately mitigate the significant adverse environmental impacts that will result from the expansion. Unfortunately, however, the City made clear they do not intend to conduct any environmental review or to upgrade the plant's outmoded and extremely harmful open ocean intakes to subsurface intakes, which are considered "best available technology" today and are required by the State Water Board of all new and expanded desal plants in California. Channelkeeper will continue to educate and advocate the Council and the Montecito Water District about the impacts and feasibility of various desalination intake technologies, current laws that require environmental review and mandate the use of less environmentally harmful subsurface intakes, and available water supply alternatives to desal that actually benefit rather than harm the environment. # Waterkeepers Sue EPA on Tap Water Safety

Waterkeeper Alliance, Waterkeepers
Chesapeake, and California
Coastkeeper Alliance filed a lawsuit
against the U.S. Environmental Protection
Agency (EPA) today for failing to revise
regulatory standards on certain

contaminants and develop new standards for emerging contaminants as required by the Safe Drinking Water Act. EPA's mandatory obligations under the Safe Drinking Water Act include identifying unregulated contaminants for monitoring and/or regulation, regulating those contaminants, and reviewing and revising existing drinking water regulations, all according to a timetable mandated by Congress. But EPA failed to perform these mandatory legal obligations and is unnecessarily putting people's health and lives at risk. Click here to learn more.

### **Recycle Film Plastic!**

Currently, Santa Barbara's waste collection service is unable to accept "film plastics," which include bubble wrap, plastic shopping bags and the plastic bags used for bread, produce and newspapers. But now, we have a solution! Channelkeeper is joining Community Environmental Council (CEC) in the effort spearheaded by Ablitt's Fine Cleaners to keep film plastic out of the waste **stream.** Community members can drop off film plastics during business hours at Ablitt's (14 W. # National Skip the Straw Day February 23

In honor of National Skip the Straw Day on Saturday, February 23, please join us in saying "no thanks" to plastic straws! Channelkeeper and our partners at <a href="CEC">CEC</a> launched the <a href="Skip the Straw SB">Skip the Straw SB</a> campaign last year on National Skip the Straw Day and worked with local students



to conduct outreach to businesses asking them to provide straws only on request and consider switching to better alternatives like reusable or paper straws. Thanks to the students' leadership, the City of Santa Barbara adopted a plastic straw ban (which goes into effect on July 1, 2019), and we are working with Carpinteria and Goleta as well to encourage them to consider

similar action. If you find yourself in need of a straw, consider bringing and using your own reusable straw; there are many great alternatives available made from bamboo, glass, or metal which are easily washable. Please help protect marine life and keep our beaches clean by skipping the straw and other single-use plastics!
