Thank You, Watershed Brigade!

The power of collective individual action was on display last Memorial Day weekend as the community responded to Channelkeeper's call to action to help keep our watersheds clean.

Due to the COVID-19 pandemic, our beaches, creeks, and rivers are experiencing a huge increase in usage these days as popular places to enjoy nature and beat the heat while social distancing. Many of these outdoor spaces are sensitive habitats. Unfortunately, we have been seeing a marked increase in trash and litter in these fragile environments, so we put out a call for willing volunteers to safely help clean up our trails, creeks, and river access areas and to help spread awareness about the need to prevent littering.

At least 25 volunteers participated in clean-up and outreach events over the holiday weekend, while following social distancing guidelines. Volunteers removed over 20 large bags of garbage from local creeks, the Ventura River, and popular trails and swimming holes. Over 300 visitors were greeted kindly with a friendly reminder to pack out their litter and over 40 sets of bags and gloves were distributed as hikers and swimmers joined in the collective effort.

**Channelkeeper Flags Under-the-Radar Desal Deal** 

Last week, Channelkeeper noticed an item on the consent agenda for the Santa Barbara City Council's June 2nd meeting which would have serious implications for the future of our city and its long-term impact on the environment. The City was preparing to sign a contract with the State Department of Water Resources for a \$10 million grant for its desalination plant, which would have obligated the City to operate the plant at full capacity (3,125 acre-feet per year, about one-third of current City demand) for 36 out of the next 40 years, regardless of whether or not desalinated water is needed or makes economic sense.

The desal plant is the City's most expensive source of water supply, requires a huge amount of energy to operate, is equipped with outdated intakes that suck in and kill massive amounts of marine life, and is currently allowed to be used as a source of supply only under emergency drought conditions. Channelkeeper quickly drafted and emailed a letter to the City Council outlining our concerns with their making this colossal obligation without any public or environmental review.

The City subsequently pulled the item from the June 2nd meeting's consent agenda and has rescheduled it for a public hearing at the June 16th City Council meeting. # ACTION ALERT! Help Us Protect Our Water Supplies From Agricultural Pollution!

Farming is an essential aspect of California's economy and way of life, but it's also the number one source of pollution to groundwater supplies and many of our rivers, streams, and wetlands. At this very moment, a new proposal (named Ag Order 4.0) is being developed to establish rules for Central Coast farmers to follow to address decades of agricultural pollution.

Channelkeeper is working with a coalition of environmental partners to weigh-in on and influence the direction of the Ag Order, and we're looking to you to help us support one of the most important pieces of the proposal.

Setting reasonable limits on fertilizer use is one of the most effective ways that our region can improve groundwater quality. Basically, we're asking state regulators to allow only as much fertilizer as crops can realistically use based on the best available farming knowledge. That's a win-win for both farming and the environment.

It may seem like common sense, but records show that the vast majority of farms

egregiously over-apply fertilizer. According to the Central Coast Regional Water Quality Control Board, over half the nitrogen applied as fertilizer ends up as harmful pollution to the environment. Currently, farms discharge nitrogen at levels ten times higher than levels that are safe for drinking water and protective of the environment. The Regional Board has issued findings that "groundwater nitrate (fertilizer) contamination is widespread and severe, and degradation is increasing in many areas." Nitrates leaching from fields into aquifers have left over 100,000 square miles of groundwater contaminated with nitrates throughout California resulting in toxic drinking water supplies.

With your help, we can tackle this problem with a solution that meets the needs of our region's farmers, the greater community, and the environment.

### **US EPA to Update Drinking Water Standards**

Our friends at <u>Waterkeeper Alliance</u> and <u>California</u>
<u>Coastkeeper Alliance</u> recently signed a <u>settlement</u>
<u>agreement</u> with the US Environmental Protection
Agency (EPA) requiring the agency to strengthen
regulations to improve the safety of our drinking water
nationwide. The settlement resolves a <u>lawsuit the</u>

groups filed in 2019 that asserted that EPA failed to update outdated standards on certain contaminants and develop new standards for emerging contaminants as required by the Safe Drinking Water Act. The settlement also establishes a timetable for regulating other existing and emerging contaminants. Channelkeeper is proud of our partners' victory that will clean up our nation's drinking water, which is unacceptably poor in many areas, particularly in underserved communities and communities of color.



## **Restoring Flows to the Ventura River Virtual Discussion**

Channelkeeper is pleased to present a webinar outlining our work to restore flows to the Ventura River on **Thursday**, **June 11th from 11 am to 12 pm PDT**. Science and Policy Director Ben Pitterle will discuss Channelkeeper's lawsuit to prevent the City of Ventura from pumping the river dry, as well as the organization's role in the City-initiated adjudication of

water rights in the Ventura River watershed. The webinar will also include a virtual tour of the Ventura River and time at the conclusion for a question and answer session.
