### **Progress on Restoring Flows in the Ventura River**



Channelkeeper is pleased to announce that we just achieved a significant win in our long-fought battle to restore flows in the Ventura River. For many years, the City of Ventura has pumped so much water out of the Ventura River that its value as critical habitat for endangered steelhead and other aquatic life has all but dried up, so Channelkeeper has been leveraging the law to bring it back from the brink - and we're succeeding. Our legal and public pressure brought the City of Ventura to the negotiating table for the first time ever, and through a formal mediation process this summer that also included the State Water Resources Control Board and California Department of Fish and Wildlife and other parties that extract water from the river. we've secured binding commitments from the City to remove fish passage barriers in the river and to reduce or curtail its pumping from the river when flows fall below critical levels for an interim period until a longer term solution is developed.

The Department of Fish and Wildlife and State Water Board are currently completing scientific studies that will determine precisely how much flow is needed to protect steelhead. Channelkeeper will leverage the agencies' studies in our continued negotiations with the City to secure a permanent solution that ensures sufficient flows in the river to sustain healthy steelhead and other wildlife while also meeting the community's water needs in the future.

## California Fights Back Against Stormwater Pollution

This week, California Senate Bill (SB) 205 was signed into law, addressing the pervasive issue of industrial facilities that remain unregulated by California's clean water laws. California
Coastkeeper Alliance and the bill's author, Sen. Hertzberg (D-LA), collaborated closely with the State and Regional Water Boards and the regulated industry to come up with an elegant solution to stormwater pollution.

California's industrial stormwater permit currently regulates approximately 10,000 industrial facilities, but there are thousands more industrial dischargers that have failed to comply. This means that when it rains, toxic stormwater pollution from unregulated facilities flows freely from oil refineries, landfills,

manufacturing plants, auto yards, and scrap metal recyclers into our waterways. SB 205 will require applicable facilities to demonstrate enrollment with the industrial stormwater permit when applying for or renewing their business license, leveling the playing field for the regulated community to help secure swimmable, fishable, and drinkable California waters.

## Paige's Big Swim for the Channel!

In the early hours of October 9<sup>th</sup>, 16 year-old Paige Kieding will dive into the Santa Barbara Channel at Anacapa Island to attempt a solo swim across the Channel to Silver Strand beach in Oxnard - a distance of about 12.4 miles. If she succeeds (and we know she will!), she will be the second youngest open water swimmer to complete this crossing. Paige came to Channelkeeper with the idea of promoting her swim as a fundraiser to support our work to protect and restore the Santa Barbara Channel and its watersheds. A lover of the ocean and passionate about ocean conservation, Paige felt Channelkeeper was the perfect fit for her fundraising campaign. You can donate and read more about her fundraiser here.
