# ACTION ALERT! Tell EPA: Now is Not the Time to Suspend Enforcement

On March 26th, the US EPA<u>announced a sweeping suspension</u> of environmental protection laws and regulations due to the current COVID-19

crisis. Please join us and Waterkeeper Alliance in signing this petition telling EPA Administrator Andrew Wheeler that it is unacceptable for EPA to suspend enforcement of laws that protect clean air and water. And If you think this couldn't happen in California, think again! Various industries are already putting pressure on the California Water Boards to loosen regulatory requirements during the COVID-19 crisis. California Cannot Afford to Suspend Clean Water Laws! Thankfully, our partners at California Coastkeeper Alliance are pushing back against polluters to protect our streams and drinking water supplies by urging Governor Newsom not to follow the feds' lead. # ACTION ALERT! Help Us Protect Our Water Supplies From Agricultural Pollution!



Farming is an essential aspect of California's economy and way of life, but it's also the number one source of pollution to groundwater supplies and many of our rivers, streams, and wetlands. At this very moment, a new proposal (named Ag Order 4.0) is being developed to establish rules for Central Coast farmers to follow to address decades of agricultural pollution.

Channelkeeper is working with a coalition of environmental partners to weigh-in on and influence the direction of the Ag Order, and we're looking to you to help us support one of the most important pieces of the proposal.

Setting reasonable limits on fertilizer use is one of the most effective ways that our region can improve groundwater quality. Basically, we're asking state regulators to allow only as much fertilizer as crops can realistically use based on the best available farming knowledge. That's a win-win for both farming and the environment.

It may seem like common sense, but records show that the vast majority of farms egregiously over-apply fertilizer. According to the Central Coast Regional Water Quality Control Board, over half the nitrogen applied as fertilizer ends up as harmful pollution to the environment. Currently, farms discharge nitrogen at levels ten times higher than levels that are safe for drinking water and protective of the environment. The Regional Board has issued findings that

"groundwater nitrate (fertilizer) contamination is widespread and severe, and degradation is increasing in many areas." Nitrates leaching from fields into aquifers have left over 100,000 square miles of groundwater contaminated with nitrates throughout California resulting in toxic drinking water supplies.

The 17th Annual Student Art Show was a great success! Channelkeeper was thrilled to host our 17th annual ocean-themed juried student art show, "What the Channel Means to Me" in early March. The goal of the show, which is open to high school students from Carpinteria to Goleta, is to inspire local youth to create art that celebrates the natural beauty and biodiversity of the Santa Barbara Channel, and for their art to inspire others in our community.

Art students from Bishop Diego, Dos Pueblos, San Marcos, and Santa Barbara High Schools submitted more than 300 works of art to vie for the chance to be featured in this year's show. Our juror, local artist and long-time Channelkeeper supporter Jeremy Harper, selected 67 awe-inspiring pieces to be in the show, as well as the first, second, third places winners, an environmental ethic award, a juror's choice award, and three honorable mentions. We celebrated the students and their incredible artwork at a public exhibit, reception and awards ceremony on March 5<sup>th</sup> at the Jodi House Gallery, where Senator Hannah-Beth Jackson joined us to present the winners with cash prizes made possible by Trillium Enterprises and the City of Goleta Community Grants Program.
