Channelkeeper and the City of Ventura Amend Settlement Agreement

Channelkeeper is proud to announce a MAJOR ACCOMPLISHMENT in our years-long endeavor to protect the Ventura River from over-pumping. Through dialogue, Channelkeeper and the City of Ventura have reached a new agreement to ensure that the City leaves a meaningful amount of water behind to keep the river flowing for endangered species, other wildlife, and recreational uses. Prior to Channelkeeper's intervention, nothing prevented the City and others from taking every last drop from the river. Now, we have secured a commitment to keep this cherished ecosystem flowing until a long-term watershed-wide solution is finalized. Strengthening Agricultural Pollution Regulations

Farming is an essential aspect of California's economy and way of life, but it's also the number one source of pollution to groundwater supplies and many of our rivers, streams, and wetlands. At an upcoming hearing on September 10-

11th the Central Coast Regional Water Quality Control Board will consider a new proposal (named Ag Order 4.0) to establish rules for Central Coast farmers to follow to address decades of agricultural pollution.

Records show that the vast majority of farms egregiously over-apply fertilizer. According to the Central Coast Regional Water Quality Control Board, over half the nitrogen applied as fertilizer ends up as harmful pollution to the environment. Currently, farms discharge nitrogen at levels ten times higher than levels that are safe for drinking water and protective of the environment. The Regional Board has issued findings that "groundwater nitrate (fertilizer) contamination is widespread and severe, and degradation is increasing in many areas." Nitrates leaching from fields into aquifers have left over 100,000 square miles of groundwater contaminated with nitrates throughout California resulting in toxic drinking water supplies.

Channelkeeper, along with a coalition of environmental partners, has worked on this issue for over a decade and will be testifying as part of the panel to move the new Ag Order forward and to ensure that it protects water quality.

Channelkeeper Supports Strong Stormwater Quality Protections

Traditional urban landscapes funnel stormwater straight to the ocean carrying trash and pollution along the way. On August 19th, Channelkeeper testified before the Santa Barbara Creeks Advisory



Committee to recommend preserving existing policies that require new development projects to treat or infiltrate stormwater into the landscape. Overtime, these water-smart actions will improve water quality, conserve our water supply, and preserve flowing creeks. This issue will now go before the Santa Barbara City Council (likely at the September 22nd meeting). Please join us in voicing your support for these important environmental protections. ExxonMobil's Interim Oil Trucking Proposal – Postponed

The County of Santa Barbara's Planning Commission was set to make a recommendation on ExxonMobil's proposal to truck oil from three offshore shut-in platforms to the Phillips 66 Santa Maria

Refinery this month. However, just weeks before the hearings (which were originally set for September 2nd and 9th), Phillips 66 announced plans to close their Santa Maria refining facility in 2023, which greatly impacts ExxonMobil's plan. With this new development, Exxon must now decide how to proceed. The new hearing dates will be announced sometime in the future, so stay tuned.



California Plastic Reduction Bills Fail

The CA Circular Economy and Plastic Pollution Reduction Act, SB54 and AB 1080, two plastic pollution reduction bills, failed to pass the California State Assembly on September 1st. These bills would have by reduced single-use plastics across California

by 75% by 2032. The plastic industry pushed back hard spending \$3.4 million on a lobbying campaign that ultimately was able to influence a few key representatives to abstain from voting. In the end, the bills fell short of passing by only by 4 votes.

The plastic industry has also been exploiting the COVID-19 pandemic by citing misinformation and fomenting fear around reusable bags and other alternatives and advocating that single use plastic is a necessary and safer alternative despite research showing that the virus can survive longer on plastic than many other surfaces.

Channelkeeper will continue our work locally to educate our community about the impacts of single use plastic and ways to reduce its use while also continuing to advocate for local policies to reduce single use plastic helping to set an example for the state. There is also a concurrent effort for a similar initiative, the Plastic Free California initiative, that has a good chance of qualifying for the 2022 ballot and will take this issue to CA voters. We will be keeping our community informed about this effort and will share upcoming opportunities to take action.
