SANTA BARBARA CITY COUNCIL TO TAKE ACTION ON CRUISE SHIP PROGRAM

On April 9th, the Santa Barbara City Council is expected to take final action on recommendations to reshape the City's cruise ship program. This represents a **culminating moment** in Channelkeeper's efforts to help shape the program's future and bring it into alignment with our community's environmental priorities.

The Harbor Commission recently approved a set of recommendations based on those developed by Channelkeeper and community partners. The Santa Barbara City Council will review these recommendations at the April 9th meeting, and take decisive action.

Public input is essential to this process. Please consider attending the April 9th meeting to share insights, ideas, and recommendations with City Council.



ADVANCING WATER CONSERVATION

Channelkeeper continues to advocate for policies to promote water conservation on both local and state levels. Our current conservation efforts are focused on ensuring that the California State Water Resources Control Board adopts strong, forward-looking water efficiency standards to protect potable supplies for our communities, which helps us to be prepared for the next drought.

In 2018, two bills were passed, <u>AB 1668 and SB 606</u>, to "make conservation a California way of life." These bills established guidelines for efficient water use and provided a framework for implementation and oversight.

To reach the conservation goals outlined in these bills, the California State Water Board is working to update its Urban Water Conservation Regulations. The revision process has been a laborious one.

On March 12, the California State Water Board released an updated draft of the Urban Water Conservation Regulations, which included language that weakens and delays meaningful conservation standards that were part of the original regulation draft. Channelkeeper staff attended the State Water Board's

Workshop on March 20th and spoke in favor of prioritizing strong conservation regulations and against delaying conservation standards.

Channelkeeper also recently joined over 100 other organizations in signing onto a <u>Statement of Principles</u> that encourages the State of California to invest aggressively in water conservation.




BUILDING MEANINGFUL CAREERS: AN INTERVIEW WITH OUR MPA WATCH INTERNS

APRIL BOARD WALK Saturday, April 20 10:00 am - 12:00 pm Cold Spring Trail

Our April Board Walk will be a loop around the Cold Spring Trail. Please meet us at the trailhead at 811 East Mountain Drive on Saturday, April 20th, to learn about the significance of this perennial stream, its journey to the Channel, and the important role that the Cold Spring plays in the surrounding ecosystem.

This short hike will be led by Channelkeeper board member Benjamin Goedert, Development Director at the Santa Barbara International Film Festival.

The walk includes a moderate climb on a dirt trail. Participants should wear sturdy shoes and bring a hat, water, and sunscreen. Any dogs joining the walk must be kept on a leash.

Channelkeeper Board Walks are occasional walks and talks around town to explore water from different perspectives. They are designed for the whole community to understand our place in nature, especially with respect to lifegiving water, and the importance of protecting our environment. Each is led by a Channelkeeper board member, drawing upon their expertise as naturalists, hydrologists, nature film producers, native plant gardeners, and more.



HELP REMOVE BEACHED LOBSTER TRAPS Saturday, April 13 8:30 am - 12:00 pm Goleta Beach

Attention volunteers! Channelkeeper has identified an onshore lobster trap debris hotspot between the Goleta Slough and More Mesa.

On April 13th, from 8:30 am to 12:00 pm, you're invited to help dig out buried lobster traps and place them at collection points along the beach where they will be loaded onto a commercial fishing vessel and transported to the Santa Barbara Harbor for reuse or proper disposal.

In addition to cluttering up our beaches, derelict lobster traps can entangle marine wildlife, release microplastics, and create safety hazards for vessels and beachgoers. We hope you'll join us and help get these traps off of the beach!

Volunteers will gather at Goleta Beach and will walk down the beach towards More Mesa to remove traps. Protective clothing and closed-toe shoes are required as traps can have sharp edges.

Volunteers will use shovels, bolt cutters, and pry bars to dig out buried traps, remove rocks and debris, and stage traps in piles for removal offshore to a commercial fishing boat. Fisherman Chris Voss from Commercial Fishermen of Santa Barbara and his team will provide vessel support to load traps and transport them to the Santa Barbara Harbor.

This is the fourth year of shoreline cleanup collaborations with the Commercial Fishermen of Santa Barbara. We're excited to work together on this community event and we hope you'll join us! Sign up below!

VOLUNTEERS NEEDED TO KEEP THE HARBOR CLEAN
Saturday, May 4
8:00 am

Santa Barbara Harbor's <u>Operation Clean Sweep</u>, a seafloor debris cleanup program, will hold its 15th annual event on Saturday, May 4th. A team of volunteer divers, supported by volunteer dock workers, will remove junk from beneath the Marina. Divers will locate the junk and dock volunteers will cart it off for disposal.

During past events, volunteers removed over twenty tons of debris from Santa Barbara Harbor, including bicycles, plastic barrels, boat propellers, outboard engines, phones, and marine batteries.

The event begins at 8:00 am, with a briefing on the Travel Lift Pier beneath the Harbormaster's Office, complete with free coffee and donuts. It concludes with a hearty lunch at 11:30 am.
